### **Process timeline for admission in 2021/2022**

#### **Determination Year 2020 – for admission in 2021/22**

1 October 2019	<b>Start consultation:</b> Earliest date to start consultation (min 6 weeks) on proposed admission arrangements (i.e. new admission policy).	
1 January 2020	<b>Deadline:</b> Local authority to formulate a coordinated scheme for state-funded schools in their area, including any new school or academy that is due to open.	
31 January 2020	<b>Complete consultation:</b> Deadline for the completion of the consultation on proposed admission arrangements.	
28 February 2020	<b>Determine admission arrangements:</b> Deadline for admission arrangements to be determined even if they have not changed from the previous year and a consultation has not been required.	
28 February 2020	<b>Deadline:</b> After which the Secretary of State may impose a coordinated scheme if local agreement has not been secured by this date.	
15 March 2020	Send determined admission arrangements to LA: Deadline for admission authorities to send a copy of their full determined arrangements to LA.	
15 March 2020	<b>Publish your admission arrangements:</b> Deadline for local authorities to publish on their website the proposed admission arrangements for any new school or academy which is intended to open within the determination year, details of where the determined arrangements for all schools, including academies, can be viewed, and information on how to refer objections to the Schools Adjudicator. Academies should also publish admission arrangements on their own school website, displaying them for the whole offer year.	
15 May 2020	<b>Schools Adjudicator deadline:</b> Deadline for objections to the Schools Adjudicator.	
30 June 2020	<b>Deadline:</b> Local Authorities to report to the School Adjudicator on admission arrangements in their area.	
8 August 2020	<b>Send info to LA:</b> Deadline for admission authorities to provide admission arrangements information to the local authority to allow them to compile composite prospectus.

## Offer year 2020 - for admission in 2020/21

12 September 2020	LA to publish prospectus: Deadline for local authorities to publish composite prospectus.		
31 October 2020	National closing date for secondary school applications.		
15 January 2021	National closing date for primary school applications.		
28 February 2021	<b>Publish appeals timetable:</b> Deadline for admission authorities to publish their appeals timetable on their website.		
March 2021 to end August 2021	<b>Late applications</b> : Parents apply to the local authority in which they live for places at their preferred primary or secondary schools/academies.		
1 March 2021	National offer day for secondary school places.		
16 April 2021	National offer day for primary school places		
30 June 2021	Deadline: Local authorities to report to the Schools Adjudicator on admission arrangements in their area.  Appeals: Admissions authority to adhere to timescales in Schools Admissions Appeals Code		
September 2021	New intake starts at school In-Year applications: Post August 2021, an application for admission between September 2021 and end of Summer term 2022 is an 'in-year' application, and parents will need to apply to the academy's admission authority directly. The LA should provide a form and info.
